Player requesting release/transfer during the competition season will be charged administrative fee.</p> <p><u>Refund policy:</u> a) All refunds and their respective amounts are at the sole discretion of the Club b) This policy applies to registration fees paid directly to Merlin Soccer Club (MSC) either online or in person c) MSC commits to program expenditures once registration numbers are determined. These expenses are not recoverable to the Club if/when a member withdraws. d) An administrative fee will be charged on approved refunds. e) MSC shall not be responsible for any monies paid to a team, team coach or team official and MSC shall not entertain requests for any such refunds. f) MSC shall not be responsible for any monies raised and collected by teams through sponsorship or fundraising efforts and shall not entertain requests for any such refunds.</p> <p>I, the undersigned, in consideration for my voluntary participation in organized soccer, do hereby willfully acknowledge that my signature below attests to my understanding and agreement that: My player status will be kept in good standing.
